# AVERAGE OIG CASE INTAKE PER SCHOOL DAY

September 1, 2019 through April 30, 2020




Prior to the closing of schools, OIG opened an average of **3.3 cases per school day** September through February 2019-20.

For rough comparison, OIG opened an average of **2.7 cases per school day** October through April 2018-19.

The number of school days in March and April 2020, as used to calculate intake per school day, is based on the current published CPS school calendar.

# **OIG SEXUAL ALLEGATION CATEGORIES**

Sexual Act	Penetration
Sexual Abuse	Physical conduct for sexual gratification, e.g., groping, fondling
Sexual Comment — In Person	Unambiguously sexual comment to student
Grooming	Actions to break down inhibitions for the purpose of sexual conduct
Sexual Electronic Communication ("Sexting")	Sexual text messages, emails, or other communications
Touching—Less than Sexual Abuse	Touching of a possible (not obvious) sexual nature
Concerning—Other	Leering, "creepy" behavior or other potentially concerning behavior
Student-on-Staff Inappropriate Conduct	Student behavior toward a staff member (now addressed by EOCO)
Outcry About Old Conduct	Recent outcry about allegations from several years ago

Cases are assigned a single category, but may involve behaviors that could fall into multiple categories. **Grooming** cases, for instance, often involve behaviors that could also be categorized as **sexual electronic communication**.


Elementary schools and high schools have similar numbers of allegations.

# SUBJECTS OF ALLEGATIONS BY JOB CATEGORY




From October 2018 through June 2019, Non-Charter schools reported 2.1 times as many cases per 100,000 students as Charter schools.

From July 2019 through April 2020, Non-Charter schools reported **1.5 times as many cases** per 100,000 students as Charter Schools. This ratio has steadily trended toward 1:1.

## **OIG CLOSED CASES**

### Summary of all OIG decisions, as categorized by initial allegation

Cases closed July 1, 2019 – April 30, 2020. A case is "substantiated" when a preponderance of the evidence establishes a violation of CPS policies, rules, or guidelines. A case may be substantiated on different grounds than the initial allegation, and in limited instances, OIG may close or refer a case without making a substantiated or not substantiated determination.

# **PERSONNEL ACTIONS**

Pulled or Blocked	As of April 30, 2020, 126 adults are currently pulled or blocked (specific to substitute teachers) from school as a result of an allegation of staff-to-student misconduct, including 40 currently pulled teachers. Additionally, OIG has issued decisions in 25 cases in which an individual currently remains pulled or blocked.
Reinstated	From July 1, 2019, through April 30, 2020, 28 pulled or blocked individuals were reinstated either based on OIG's recommendation, or after the conclusion of OIG's investigation of allegations.
Terminated or resigned/retired	35 adults who were subjects of an investigation were terminated or resigned/retired from July 1, 2019 through April 30, 2020.

As of the May 2020 Board Report, the OIG has updated the subject job categorizations to provide greater specificity and capture more information regarding subjects of allegations. For instance, previously a Teacher who also worked as a Coach might have been categorized as either a 'Teacher' or a 'Coach.'

The OIG now categorizes the individual in the most specific category applicable to the capacity in which the individual was working when the alleged conduct occurred. Thus, a Teacher who happens to coach, but who was not in a coaching role when the alleged conduct occurred, is categorized as 'Teacher.' Had the same individual been serving in a coaching role when the conduct occurred, the OIG would apply the 'Teacher-Coach' category.
